DESCRIPTIONS OF THE RESTRICTED FUNDS

Lost River State Park Fund: Created with \$2K donation in 2004. Fund will be used for improvements as requested by the Superintendent of the Lost River State Park. There has been no activity since 2004.

Valley Falls State Park Fund: Funded by a \$32,260.60 bequest from Ada Counts in 2005. Principal is restricted, accrued interest can be spent on Valley Falls State Park improvements per request of Park management.

Chief Logan State Park Fund: Created in 2005. Fund will be used for construction of a handicap children's playground in the Chief Logan State Park. Initial donations were from two fund raising events at the school in 2005, but no activity since then.

DNR Nature Centers & Environmental Programs Fund: Created in 2005. Supported by lodging donations and unrestricted donations to the Foundation. Spending decisions are made upon request of the WVDNR Parks Management.

Coopers Rock State Forest Fund: Started with donation by Dr. Charles Stewart in 2006 for installation of a handicap accessible fountain. The fountain was installed in 2007 and no activity since then.

Bluestone State Park Fund: Created in 2007.

Blackwater Falls State Park Fund: Created in 2007. Donations and expenses were to purchase playground equipment u\in 2010.

Cacapon State Park Fund: Created in 2007.

Pipestem State Park Fund: Created in 2007.

Seneca State Park Fund: Created in 2007.

Greenbrier State Forest Fund: created in 2008. Donations to date have been for construction of a disk golf course and support of the shooting range.

Audra State Park Fund: Created in 2008.

Cashdollar Fund: created in 2011 with a \$166K bequest from the estate of Kenneth L. Cashdollar "for maintenance, construction and improvement of hiking trails, overlooks, and nature centers. Preference for Blackwater Falls, Twin Falls, or Tygart Lake State Park."

Blackwater Video Fund: Created in 2011 to support the post-production work and marketing of the video "Blackwater Canyon: Portrait of the Wild Lands". Funding is from a grant from the WV Humanities Council.

Tomlinson Run State Park Fund: Created in 2011. Received a 2011 donation from the WV DNR to pay for paving in the Park that was completed in 2011.

Laurel Lakes WMA Fund: Created in 2012 to accept donations for the purchase of playground equipment at the WMA.

Watters Smith State Park Fund: Created in 2012 to accept donations for construction of a trail bike washing facility. It was completed

1. Donations received from guests at parks with lodging facilities are placed in the DNR Nature Center and Environmental Programs Fund. Lodging donations received this year were:

2. Interest income is allocated to the restricted funds based on their average balance during the year. Funds with an average balance less than \$400 do not get interest.

3. The Foundation received a \$166K bequest from the estate of Kenneth L. Cashdollar in 2011. To date that money is unused and is awaiting projects for the maintenance, construction and improvement of hiking trails, overlooks, and nature centers in Blackwater Falls, Twin Falls, and Tygart Lake State Park.

4. Major Foundation expenses in 2012:

- ** \$498 for a mountain bike washing station at Watters Smith State Park.
- ** \$174 for playground equipment at Audra State Park.
- ** \$609 for post production work on the video about the history of Blackwater Falls State Park.
